**DESCRIPTION**

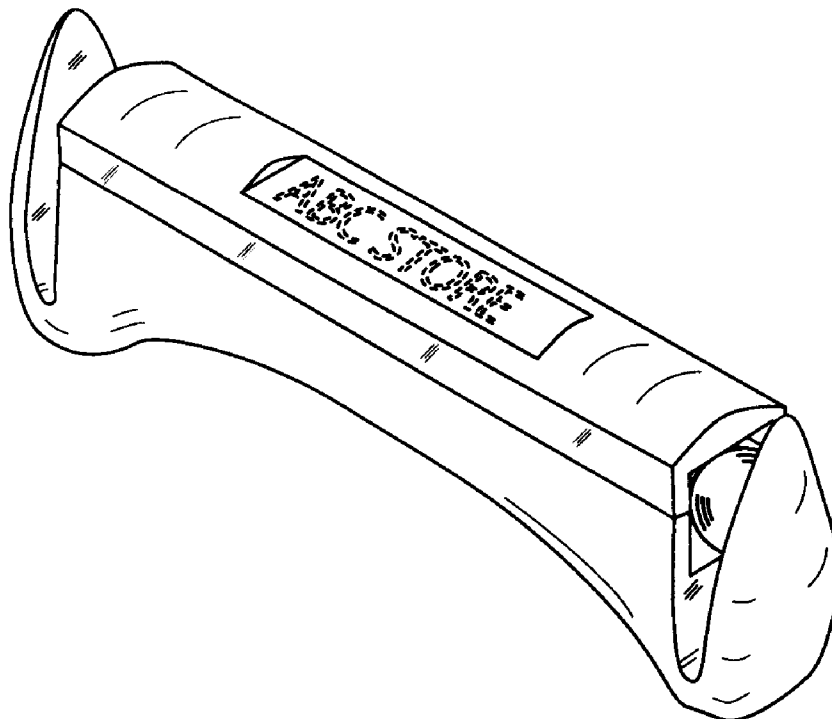
FIG. 1 is a perspective drawing of the invention, illustrating an optional logo in phantom outline;

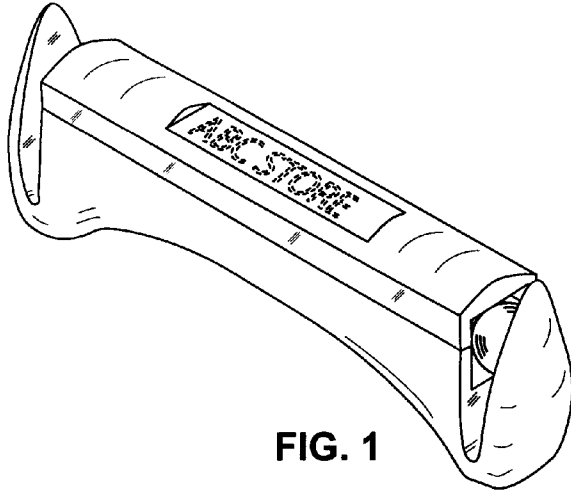

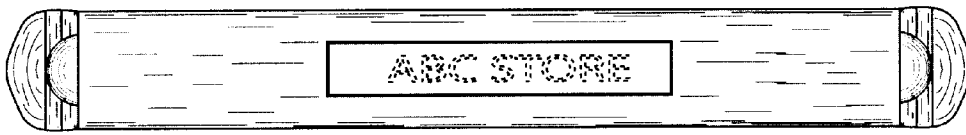

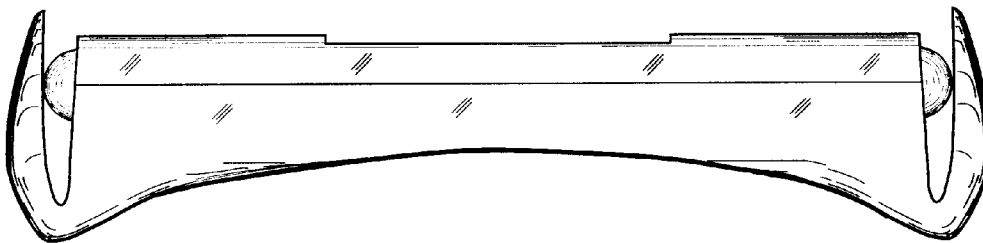

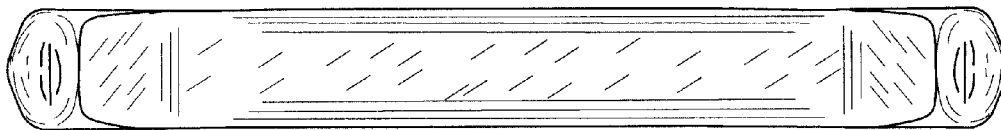
