(57) **CLAIM**

I claim the ornamental design for a political board game, as shown and described.

**DESCRIPTION**

FIG. 17 is a front elevational view of a sixteenth playing card thereof;

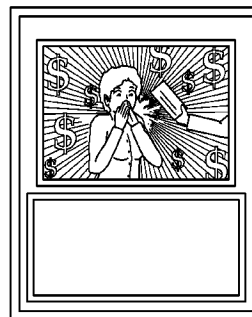
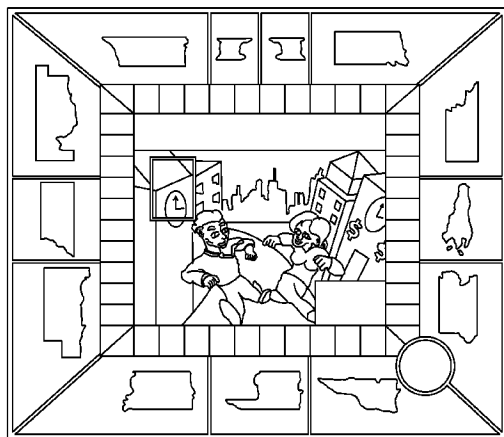
FIG. 18 is a front elevational view of a seventeenth playing card thereof;

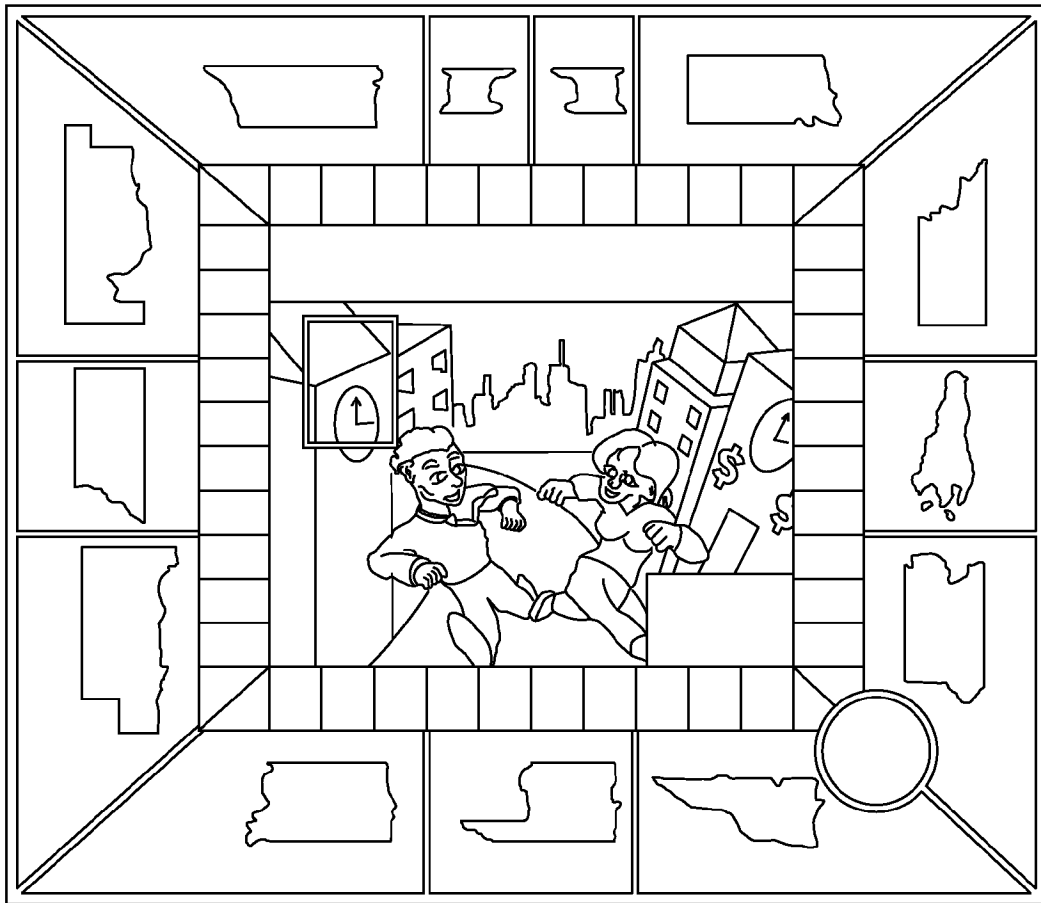

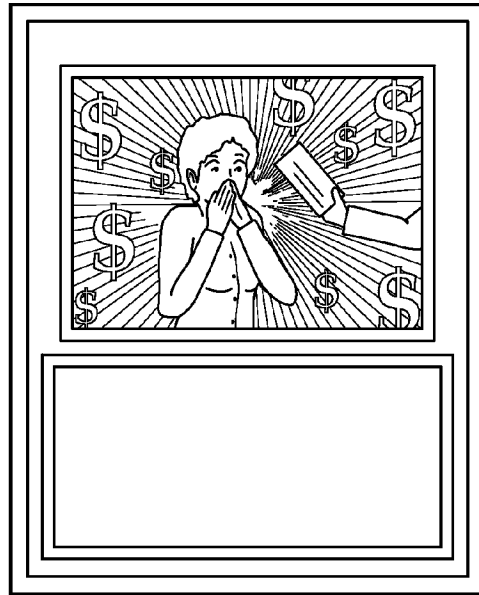

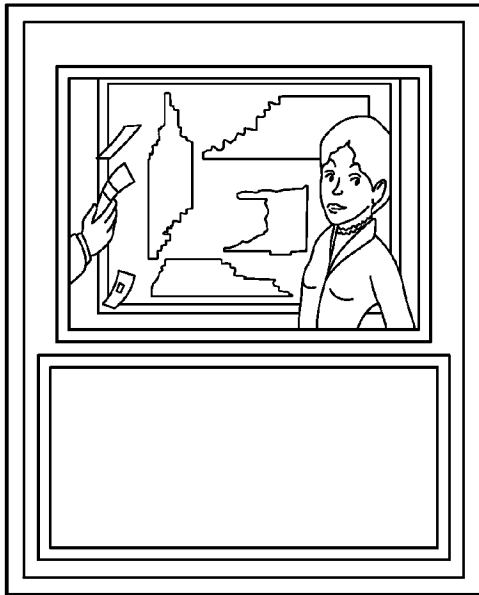

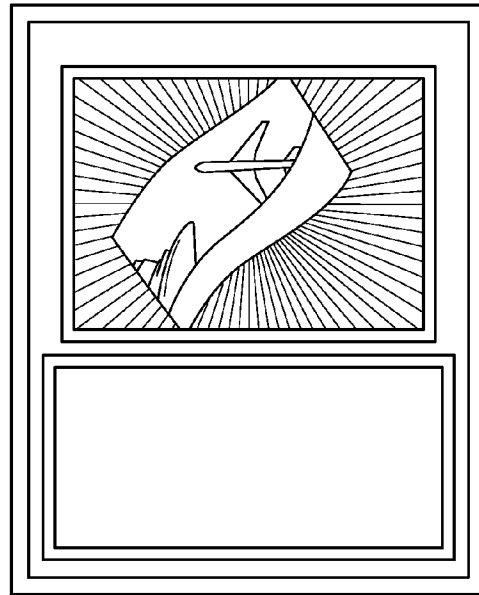

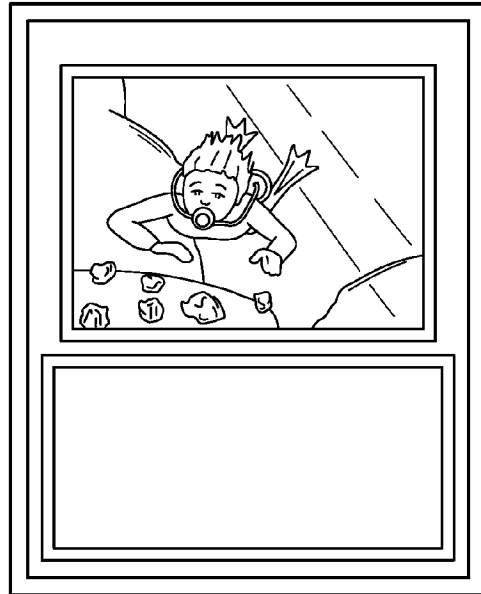

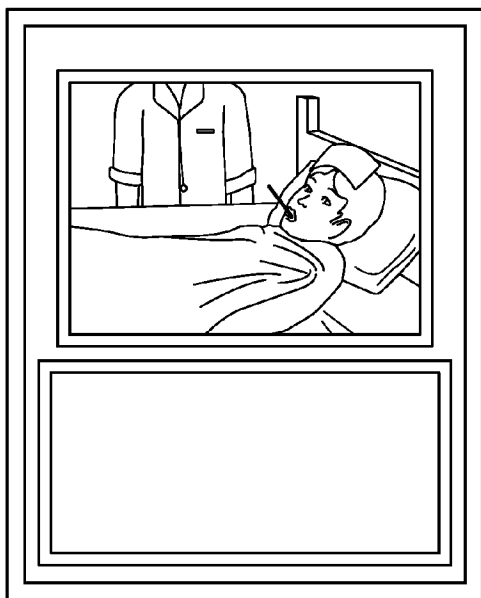

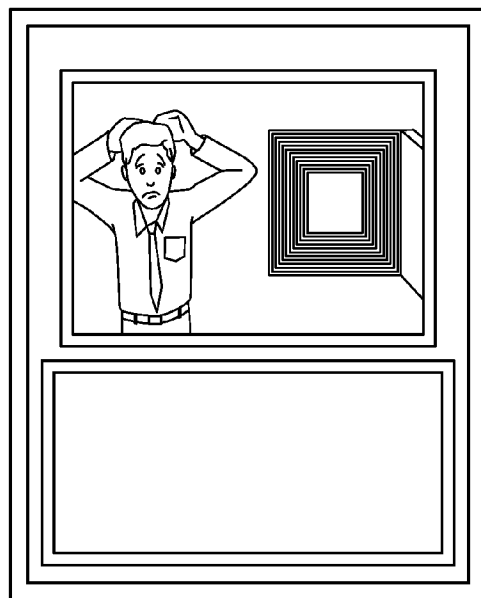

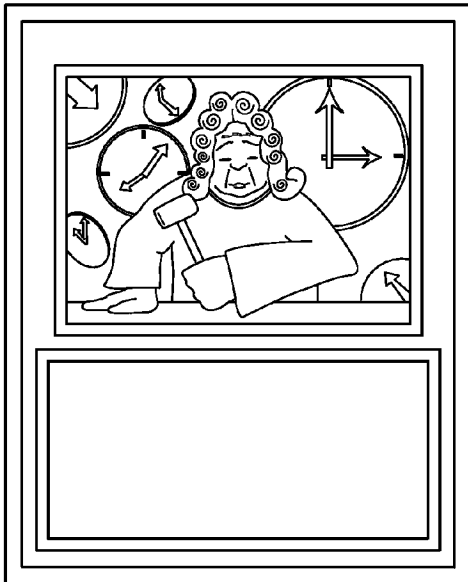

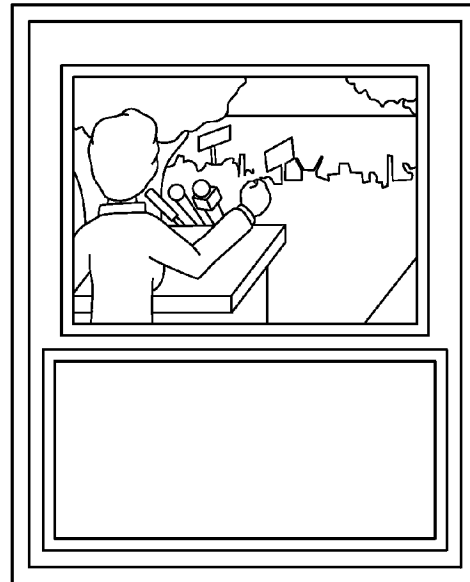

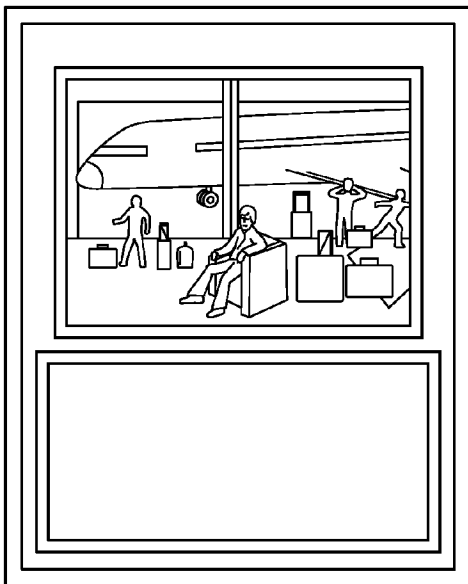

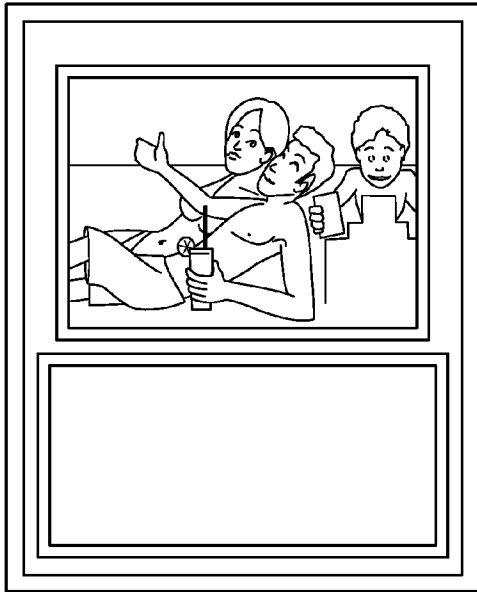

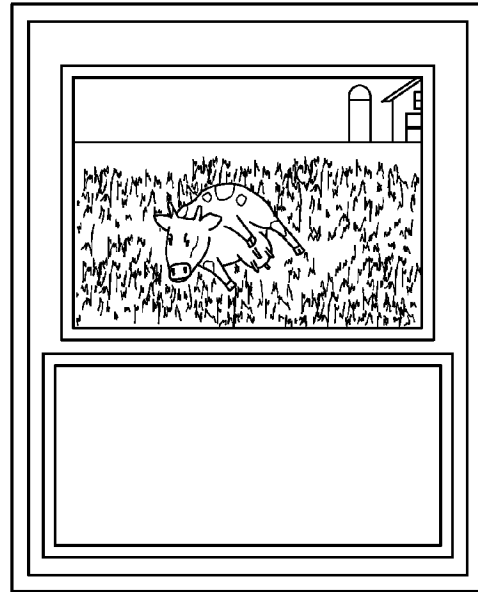

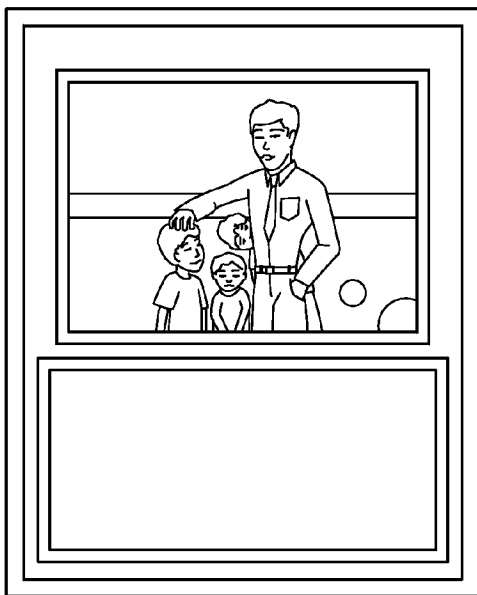

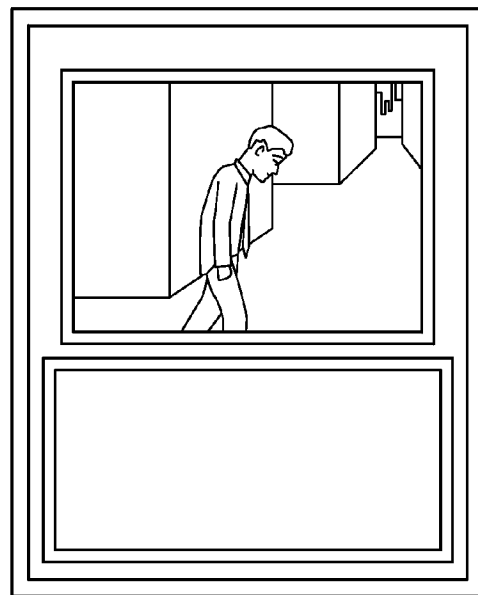

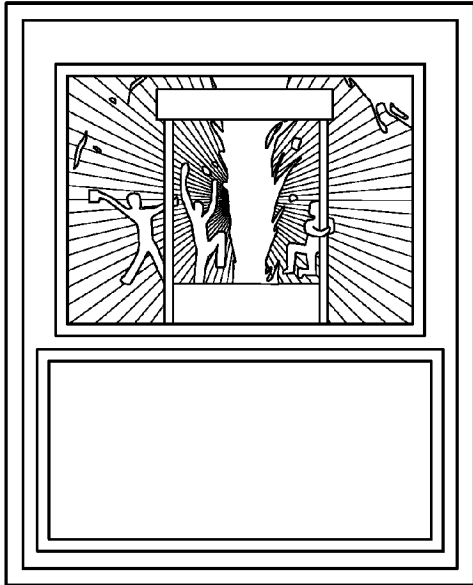

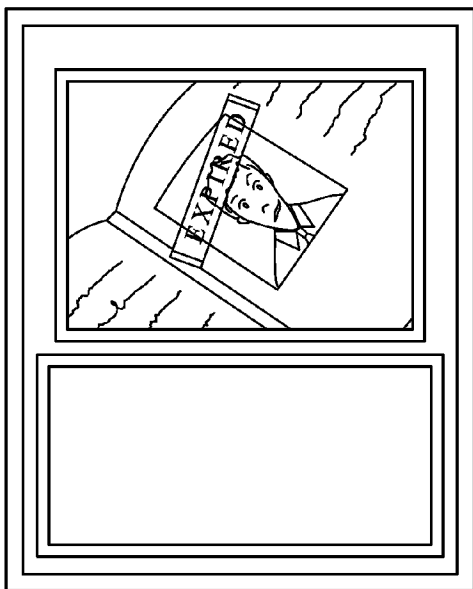

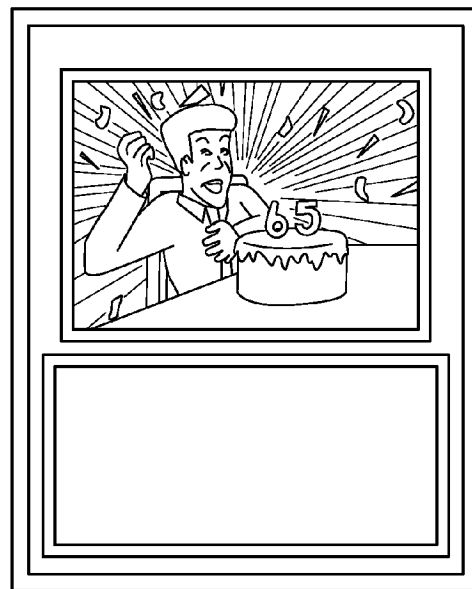
